

Emissions reduction targets

We are projecting our carbon emissions will decrease by 18% over the next 5 years with the implementation of our detailed carbon reduction projects. With the aim to be at Net Zero by 2045 in line with the UK Government guidelines.

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 526 tCO₂e by 2028. This is a reduction of 18%



Carbon Reduction Projects:

Including but not limited to:

- Use of Public Transport encouraged for all team members where feasible.
- Moving to LED lights in home offices.
- Zoom/Team favoured where possible to reduce travel need.
- Financial incentives for hospitals to bulk order reducing the number of deliveries.
- Regular meetings with procurement/logistics teams at hospitals to ensue no need for expedited deliveries.
- Regular company meetings to share relevant government schemes aimed at reducing carbon footprint in the office/home.
- Encouragement of team to move to electric/hybrid transportation.
- Carbon-Off Set Schemes to be reviewed regularly to help meet tCO₂e targets.
- Expired stock re-purposed for training events to reduce waste.
- Selection of 'Green Conscious' Hotels when overnight stays are required.
- Selecting the 'Carbon Off-Set' option taken for flights where possible.
- Engagement with upstream supply chain to implement greener protocols to reduce cope 3 emissions.
- Encouragement of team to not print items unnecessarily & to recycle where possible.
- Engagement with supply partners to explore more carbon-efficient manufacturing processes and greener routes to market.

These schemes will be assessed annually at the AGM and new technological advances as well as success of the schemes will be evaluated and developed accordingly.
